William Merrigan, Volunteer Driver Retires After Long Service to SCMAFC

Bill was born in 1934 in a farm house in Conception Junction, Missouri and lived there through high school. His house was across the road from a Benedictine Monastery where Justice Clarence Thomas was a student. Bill received a BA degree from Creighton University in Omaha. He subsequently served in the U.S. Naval Air Corps and later graduated from Georgetown University law school while working for U.S. House of Representatives Missouri Congressman W.R. Hull, Jr. After admission to the Missouri and Virginia Bar Associations Bill lived in Asia for about 16 years working as Counsel for various CIA-connected airlines, including Civil Air Transport, Air America, and Southern Air Transport. At the end of the Vietnam War Bill returned to Washington as an attorney for the Department of Defense, representing DoD in such areas as the Civil Aeronautics Board, the Interstate **Commerce Commission, and several hearings** before Congress. After retirement he worked with Congress for several years to develop legislation that would grant civil service retirement benefits to former employees of companies. Ironically, after 18 years Bill expects this legislation to be passed within the next few days. There are now more than 120 representatives in the House that have signed on as co-

sponsors of the bill with an equivalent proportion of Senators sponsoring an identical Senate version (H.R, 1297 and S.407).

Bill has been married for more than forty years to Sandra Whipple Merrigan, who was formerly of Seattle and who lived many years abroad.

Audrey Levin, a Nonagenarian Client Audrey Lapp Levin has been riding with us for 10 years and is one of our drivers' favorites, always in good cheer with a smile on her face. She grew up on Long Island and attended the Pratt Institute in Brooklyn, where she studied the arts. This led her to a position as a fashion copy writer in New York for Montgomery Ward's catalog. A few years after WWII she became reacquainted with a friend, Stan Levin, who she had met at age 12, and married him. In the war Stan flew as an Air Force navigator in the Pacific. The two initially lived in Westbury, Long Island, where they raised two children. Later they lived in Williamsburg, VA, for 15 years and then moved to McLean to be closer to their children and four grandchildren. In August, Audrey will visit for the first time her new great-granddaughter in California.

**Ines Chamorro, Featured Client** Ines was born in the 1930s as one of eight children in Pasto, Colombia, near the border with Ecuador. Her father, a concert violinist, moved the family to Bogota where she attended Javeriana University, studying human relations and economics. In 1962, Ines attended a Pan-American Union violin concert in Washington, D.C. that led to a job in the Music Division of the Organization of American States (OAS). While working Ines also attended George Washington University, graduating with a degree in Anthropology. OAS promoted Ines to be head of the Cultural Heritage Division, with projects in many parts of the U.S., North and South America, and Europe. In 1990, as part of the 500th year celebration of Columbus' arrival in the New World, the King of Spain presented Ines with a coveted Premio Tenerife award for her contributions to arts and crafts in the Americas and Spain. Ines lives in McLean with her sister Marina and Ines has a nephew, Adrian Chamorrow, who lives in Paris working as a concert violinist and conductor maintaining the family tradition.
